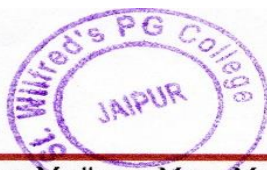
Participants learned about the different types of claims and their role in the patent examination process.

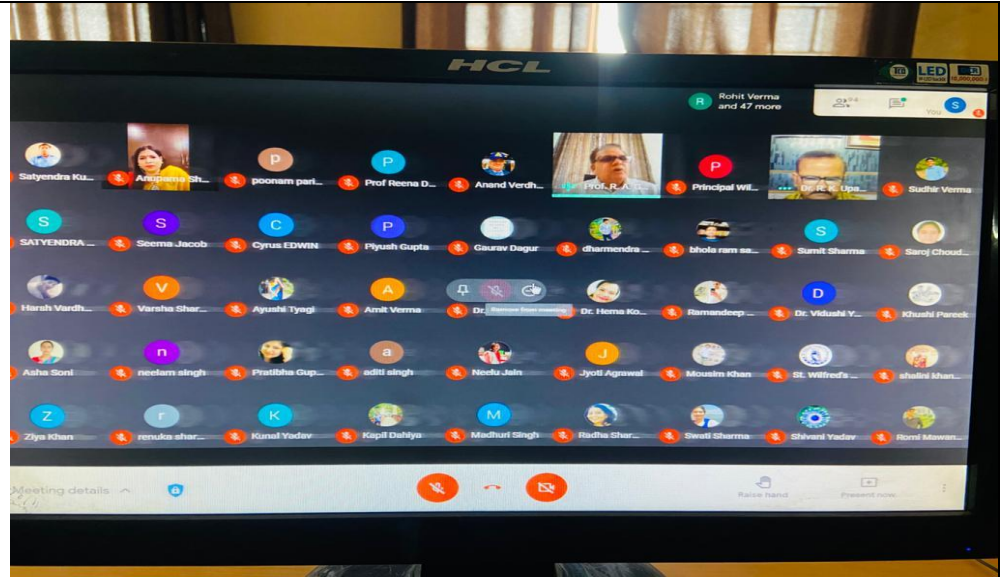

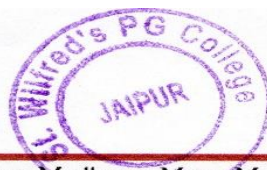

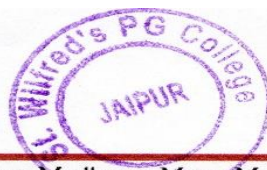
